BACKGROUND

It is a precondition to effective contacts across Member States, which are in turn the cornerstone for judicial cooperation. It is essential that all stakeholders pay attention to training on legal terminology of foreign languages”.

EJTN is focusing special attention to designing linguistic projects for the training of the EU judiciary in legal English and legal French.
