

## AIKOS PROGRAMME

### GREECE – NATIONAL SCHOOL FOR THE JUDICIARY AND GENERAL PROSECUTOR'S OFFICE



#### Description and objectives of the AIKOS Programme

The EJTN AIKOS Programme is addressed specifically to future and early-career judges, giving them the opportunity to learn about other judicial systems and training curricula, enhance their knowledge of EU law and judicial cooperation instruments as well as meet with their counterparts and develop useful contacts for their future professional life.

The AIKOS Programme's objectives are:

- To bring together future or newly appointed judges from different EU Member States;
- To foster mutual understanding of different European judicial cultures and systems;
- To raise awareness of the European dimension of their (future) work.

## NATIONAL SCHOOL FOR THE JUDICIARY



#### Specificity of the host institution

The National School of the Judiciary is the sole Institute in Greece that is entitled by the Greek Law to train judges, administrative judges and prosecutors in order to preside (Initial Training) in Courts and educate judges, administrative judges and prosecutors to be tutors in the School and participate to domestic and foreign conferences etc (Continuous Training and Education)

#### Key points for the host institution's programme

- Obtain knowledge of EU law (conference, seminar etc. about an EU law topic)
- Acquaintance with the Greek Courts and Detention Centre
- Participate in a School lesson
- Socialize with the Greek students and tutors
- Visit the most interesting sites of Thessaloniki



### **Content of the host institution's programme**

- Seminar with EU subject (preliminary procedure, judicial cooperation in civil and criminal matters, European arrest warrant etc.)
- Visit to the Court House – meet judges and prosecutors, attending trials etc.
- Attending classrooms (EU law, the preliminary question, communication and social media, cybercrime, connecting international crime movies with judicial reality)
- Presentation of the judiciary system of the hosts and the participants
- Visit to the detention center

### **Additional information**

- The seminars are held in Greek with a simultaneous translation
- The groups are consisted by students of the School and the foreign students

## **GENERAL PROSECUTOR'S OFFICE OF THE SUPREME COURT**

### **Specificity of the host institution**

The Department of International Relations and Lifelong Learning of Prosecutors of the General Prosecutor's Office of the Supreme Court is responsible for : the organisation of educational seminars, the planning of training programs and the participation of the national Public Prosecutors in European training programs, and educational and training networks, in conferences, lectures, seminars, on the prevention and suppression of modern forms of criminality in cooperation with national, European and international institutions, such as, for example, the European Judicial Training Network (EJTN), the European Union Agency for Law Enforcement Training (CEPOL), the Office for Democratic Institutions and Human Rights (ODIHR), the European Union Agency for Fundamental Rights (FRA) and the Academy of European Law (ERA) as well as with educational institutions and other education or other professional bodies providing training, of the public or private sector, national or not or with persons of recognised scientific excellence.

### **Key points for the host institution's programme**

The intention of the Department of International Relations and Lifelong Learning of Prosecutors of the General Prosecutor's Office of the Supreme Court of Greece is to schedule visits at the Prosecutor's Office at the First Instance Court, the Appeal Court of Athens and the Supreme Court. The participants will also visit the Hellenic Financial Intelligence Unit (FIU) and the Prosecutor's Office for Combating Economic Crime. They will also visit special departments of the Hellenic Police, such as the Forensic Science Division, the Cybercrime Unit and the Special



Violent Crime Squad (Anti-Terrorist Unit). Finally, a whole day will be dedicated to a visit at Special Detention Centers, located outside Athens.

The visits, in one group, at the aforementioned Courts, Special Prosecution Offices, Special Departments of the Hellenic Police, as well as the Special Detention Centres will have the seminar -like format, i.e. prosecutors, police officers and experts -specialized at their field- will make presentations of the way their office/service/department works. After each presentation a discussion will follow, so that the participants may speak about their own experience concerning these aspects of the judicial system of their countries.
